


# Guardian's Guide to Privacy & Security

## Privacy & Security in the classroom

G Suite for Education core services and Chromebooks support compliance with rigorous standards -including FERPA<sup>1</sup>, COPPA<sup>2</sup>, and the Student Privacy Pledge. Schools are required to evaluate and select tools and in some cases, gather parent/guardian consent for the use of them. ## What is Google doing to protect my child's privacy?

Google provides safeguards and privacy policies that put schools in control of their own data. Here's how you know that your child is protected.

**🛡️ Data is kept secure**  
Schools own their own data and use Google's secure servers and platform services, making it easy for school administrators to monitor and manage data security. To learn more, visit [Google for Education's YouTube channel](#).

**📄 Compliant with industry regulations and best practices**  
Independent organizations have verified Google's services to ensure their data protection practices meet the standards and industry regulations. To learn more [watch this video](#).

**🗨️ An ad-free environment for our students**  
There are no ads in any of the G Suite core services, and Google does not collect or use K-12 student data for advertising purposes or to create advertising profiles. K-12 students do not see ads while searching on Google when signed in to their G Suite for Education accounts. To learn more [watch this video](#).

**👤 School-managed Google account**  
Students are provided a separate Google account to use for educational purposes. This enables schools to use the appropriate online privacy & security settings protecting student data from being stored, repurposed, or provisioned by third parties, especially when it comes to personal information.


## What about student Digital Wellbeing and Online Safety?
